Our Approach

Unlike other forms of dispute resolution we do not offer evaluations of the strengths or weaknesses of a party's case. Instead we help them to develop outcomes that all are willing to accept. As Doughty Street mediators we build on our strengths, including an unrivalled capacity to promote effective communications and develop consensus between parties. Our role includes helping them to test the reality of the positions they may adopt. We also bring experience, commitment and above all creativity and innovation in our approach.

What We Do

Mediation is

"quicker, cheaper and less stressful and time-consuming than litigation" "more flexible...less likely to be harmful to the long-term relationship between the parties" and "far more likely that both parties will emerge as 'winners'." - Lord Neuberger, then President of the Supreme Court

So for those not already familiar with mediation, we can say with confidence that mediation works!



Our mediators regularly act as third party neutrals, helping all parties involved in disputes to arrive at settlements that meet their needs and that avoid or curtail litigation. We ensure that with our support, the parties come to their own agreements so that the wider issues are taken into account to address the parties' particular needs. Given its high success rate and that its cost is a fraction of the costs of protracted and expensive litigation, mediation regularly proves to be a worthwhile investment.

The mediation process may take place on a single day, or in shorter sessions over a period of time, according to the needs of the parties. We are flexible in tailoring the process to meet the particular complexities of each dispute – whether it involves multiple participants with widely diverging interests, or parties who want to safeguard their future relationships. Our creative approach aims to give participants opportunities for a wide range of outcomes often not available in litigation.

Confidentiality and building trust are cornerstones of our mediation practice. Our skilled mediators facilitate the resolution of disputes by encouraging participants to discuss in confidence the issues that they face. Parties can be secure in the knowledge that what they say is private and without prejudice, so that nothing said in the mediation is admissible if legal proceedings should follow.

Cases we mediate

Our mediators believe that virtually all disputes have the potential to be resolved through mediation – and most are, either on the day of the mediation or soon afterwards. Practical resolution by mediation can provide tangible results which are not restricted by private or public law principles of remedy.

Examples of some of the sectors and cases we mediate include:

- Public sector entitlement to housing, community care, mental health aftercare
- Court of Protection families and statutory bodies about best interests of adults lacking capacity
- **Police** malicious prosecution and false imprisonment, internal employment issues
- Workplace and employment unfair and constructive dismissal, discrimination issues, workplace conflict
- **Professional Negligence** claims for damages against health trusts and other organisations, solicitors, accountants
- **Media** claims for breach of copyright, defamation, misuse of private information, breach of confidence
- Commercial contractual, partnership, fraud, intellectual property
- International longstanding conflicts between state and community groups
- Property/real estate landlord tenant, neighbour disputes, party wall, trust of land
- Probate disputes validity, knowledge, fraud, undue influence, executor duties, inheritance
- Education



Independent Facilitation and Neutral Chairing

Doughty Street Mediators regularly act as independent facilitators in contexts such as round-table discussions, negotiations, problem-solving meetings and Restorative Justice processes. Because we are independent we are able to bring an element of objectivity to a wide variety of situations. We enable participants to have difficult conversations that may otherwise have stalled. We can offer fresh perspectives on stuck situations. In this way parties are enabled to manage their differences and avoid what might otherwise become a conflict.

In the workplace, whether with executives, employees or other key stakeholders, we bring skills in communication and relationship-building. This can result in rapid and resource-effective resolution or a comprehensive framework for future action.

We work with parties to develop an independent facilitation process designed to fit their specific needs. Our ethos brings a commitment to open dialogue, where we aim to ensure all voices are heard and all issues can be raised, enabling positive next steps to be taken.

Our impartiality and neutrality in facilitating internal dispute management processes

- Encourages participants to engage with openness and transparency
- Supports impartiality and independence in decision making
- Secures engagement in the outcomes and thus in ongoing relationships

Conflict Management and Resolution

While disputes tend to be around shorter-term differences, conflicts may have longer-term and deep-rooted issues which seem to be less easily negotiable. A number of our mediators have worked successfully in conflict resolution, in both domestic and international contexts.

Examples include

- mediating with a large multinational corporation and its workforce
- mediating in the Colombian peace process
- leading courses developing cross-cultural understanding
- chairing an international peace-building NGO



LAWRENCE KERSHEN KC CALL: 1967 SILK: 1992


Lawrence brings a wealth of experience to mediation and ADR and has practised as a mediator since he was accredited by CEDR in 1994. With experience in a variety of disputes and a range of sectors, his mediations include commercial contracts, banking and financials ervices, construction and engineering, defamation, fraud, inheritance, insurance, intellectual property, manufacturing, media, partnerships and shareholders, police, professional negligence, property and voluntary organisations. He has experience in cross-cultural disputes and has been accredited as a Restorative Justice facilitator.

He practised as a barrister and then KC for more than 30 years in a broad range of civil, commercial and complex criminal cases, and sat as a Recorder of the Crown Court. He acted as observer for Amnesty International in trials in the Gambia, Israel and Grenada, and in 1991 mediated between the Government of Grenada and 14 death row prisoners. Lawrence now works exclusively in mediation and facilitation and trains others in mediation and negotiation skills.

He has also been active in conflict resolution and chaired Search for Common Ground in the UK for 10 years, supporting the international work of SFCG Washington in conflict transformation and peace-building. He has been actively involved in the development of Restorative Justice and was a board member then chair of the Restorative Justice Council. He is a member of the working group on Environmental Restorative Justice of the European Forum for Restorative Justice.

Recognising the importance of enhancing communications in resolving disputes, Lawrence is accredited as a trainer of Nonviolent Communication and Neuro-Linguistic Programming. He has been selected by Who's Who Legal 2020 as 'one of the world's leading mediators' and included in the Legal 500 Mediator Hall of Fame 2020.





HEATHER ROGERS KC CALL: 1983 SILK: 2006

Heather trained as a mediator with the London School of Mediation at Doughty Street in 2012. She has extensive experience in media and information law, including defamation, misuse of private information/ breach of confidence, data protection, and other litigation relating to publishing, broadcasting and film. She has experience of mediation in these areas both from the perspective of representing parties in the mediation and as a mediator. She has acted as a mediator in publication cases that have involved disputes between individuals, as well as in matters involving the media. As a mediator, she is able to act whether or not the matter in dispute requires specialised knowledge of these areas of law.

Professional practice aside, Heather has been a Recorder in the criminal courts since 2010; she was a member, and then Chair, of the Inns' Conduct Committee (a professional disciplinary body) until her extended term of office ended in 2018; she is a member of the arbitrator panel for IPSO (independent press standard organisation); she was Trustee of Article 19 (an international free speech NGO) from 2004 to 2012; and she is currently a director of the Campaign for Freedom of Information.

As a former partner in a busy legal aid firm, she has a keen understanding of the importance of early resolution of conflicts.

Sophy was accredited as a mediator by Regents University, London in 2014, and finds her mediation skills invaluable in many aspects of her work. She has a busy practice in the Court of Protection where Mediation and other forms of Alternative Dispute Resolution are increasingly encouraged. She regularly facilitates Court of Protection round table meetings on behalf of the Official Solicitor, in cases where dynamics between the parties often become complex, and participants can feel mistrustful of each other.
